PRODUCT WARRANTY

LIMITED PRODUCT WARRANTY; SOLE AND EXCLUSIVE REMEDY.

Spectralink warrants to the end user ("you") that this Product will be free from defects in material and workmanship, under normal use and service, for one (1) year from the date of purchase (the "Warranty Period"). Spectralink's sole obligation and your sole remedy under this express warranty shall be, at Spectralink's option and expense, to repair the defective Product or part or deliver to you an equivalent Product or part to replace the defective item. All Products or component parts that are replaced will become the property of Spectralink. Replacement Products or component parts may be new or reconditioned. Spectralink warrants that any replaced or repaired Product or part will be free from defects in materials and workmanship for ninety (90) days from shipment, or the remainder of the Warranty Period, whichever is longer.
